Paintball Rules of the Game

Before entering the Hawkesbury Paintball playing field; All persons, player or spectator must read and sign the 'Conditions of Participation' further detailed on the reverse side and in so doing understand, acknowledge and agree to abide by the conditions as set out by Vanguard 2012 Pty Ltd t/a Hawkesbury Paintball in the following rules:

1. All instructions and decisions of the referees and Hawkesbury Paintball staff must be followed at all times. I agree to follow all instructions given by referees.
2. Only approved safety equipment shall be used, all private equipment must be submitted to Hawkesbury Paintball Management for examination prior to use.
3. Protective clothing including face mask/ goggles must remain on at all times unless instructed otherwise by Hawkesbury Paintball staff.
4. No player shall fire upon another player at a range closer than six metres.
5. No player shall deliberately shoot anyone in the head or face areas not covered by a mask.
6. No player shall deliberately shoot their Paintball markers at any time whilst moving between gaming zones.
7. Hawkesbury Paintball Management reserves the right to remove immediately from the game, field or property any person or group who in the opinion of Hawkesbury Paintball or its staff has breached any of these rules or is engaging in any behaviour, which Hawkesbury Paintball or its staff consider to be unacceptable or dangerous. Police maybe also informed of any unruly or dangerous behaviour.
8. The Above Rules are not exhaustive and any person on the property must abide by directions of the Hawkesbury Paintball Management and Staff.

CONDITIONS OF PARTICIPATION

1. I have read this document and participated in the safety information session prior to participating and fully understand the rules of the game paintball conducted by Vanguard 2012 Pty Ltd T/a Hawkesbury Paintball and their Management and staff, and I agree to abide by those rules during my participation in the game.
2. The game is physically and mentally intense and requires extreme exertion to play. I am physically fit and mentally able to take the strain and exertion involved in playing the game. I have no disability, impairment or health condition which would be detrimental to my health or safety, or safety of other persons in participating. I am not under the influence of any drugs, alcohol or controlling substances. It is the player's responsibility to rehydrate themselves during breaks.

3. Participation in the game may be hazardous and can result in serious injury.
4. The game can be dangerous if not played exactly in accordance with the rules. Paintballs may bruise or break the skin. Only Paintballs purchased from the Vanguard 2012 Pty Ltd T/a Hawkesbury Paintball Office can be used on the Fields.
5. Employees, servants or agents of the company have no authority to accept goods or articles for safe custody from any person and the company shall not be responsible for such loss or damage (no matter how or why it occurs) to any such goods left at the premises of the company including carpark or adjoining areas.
6. No agent, servant or representative of Vanguard 2012 Pty Ltd T/a Hawkesbury Paintball has authority to alter, modify or waive any of the above conditions.
7. I am fully aware of the risks to myself and others in playing the game. I have agreed to participate in the game, and use the services of Vanguard 2012 Pty Ltd T/a Hawkesbury Paintball and the equipment supplied, entirely at my own risk.
8. Any breakage or loss of Vanguard 2012 Pty Ltd T/a Hawkesbury Paintball equipment loaned or hired to me during the day will be charged to me at cost price.
9. There may be no or inadequate facilities for treatment or transport of me if I am injured. I understand that the property where the Paintball games are conducted are in a hilly, bush and rocky covered area which in some parts has fallen trees, ferns and other natural ground coverage. I also understand that due to the location there maybe flora, reptiles, spiders etc which maybe venomous or noxious.
10. I hereby release forever discharge and agree to indemnify and keep indemnified the company, its officers, employees, agents and contractors from any and all claims, suits, demands, expenses, costs, actions, proceedings of any nature whatsoever, which I, my executors or administrators or any other person has or might assert on my behalf arising from, in relation to, incidental to or by virtue of any deaths, injury, loss or damage suffered or sustained by me in connections with my playing paintball or at any time I am on or near the property occupied by Vanguard 2012 Pty Ltd T/a Hawkesbury Paintball, notwithstanding whether such death, injury, loss or damage is due directly or indirectly from any negligent act, omission, default, breach of duty, breach of statutory duty, or breach of control by or on behalf of the company, its officers, employees, agents or contractors.
This release, discharge and indemnity shall be deemed to extend to:
 - a) Any death, injury, loss or damage arising out of the supply of faulty or inadequate equipment.
 - b) Any death, injury, loss or damage suffered or sustained by any other person as a result of my negligent act, omission, default or breach of any duty or contract.
11. I release, approve and consent to Vanguard 2012 Pty Ltd T/a Hawkesbury Paintball to use any and all images and footage, my name and likeness recorded on the day. I further understand the images or footage in whatever form of recorded media remains the property of Vanguard 2012 Pty Ltd T/a Hawkesbury Paintball and that there will be no restrictions on the number of times that my name and likeness may be used.
12. I agree to leave my identification with Vanguard 2012 Pty Ltd T/a Hawkesbury Paintball while playing the game. I agree to be responsible for my equipment and agree to pay up to \$500 if lost or damaged.
13. When supplying your email address you may receive occasional promotional material. It is our policy to only email customers who give us permission to do so. If we send you an email for a commercial purpose, we will give you the option of not receiving further communications of this nature. We take your privacy seriously as such, your information will never be shared or sold to any 3rd party.
